Description of situation:

Unfortunately it is dissatisfying that the implementation of the standard ISO 9001:2015 is officially ahead and closed for the manufacturers of the mandatory application of ISO/IEC 80079-34:2018 and EN ISO/IEC 80079-34:2019 respectively.

Thus for customers and for the Notified bodies' auditors arise the difficulty, which standard to apply for the foreseen QAN audit before EN ISO/IEC 80079-34:2019 is finally confirmed.

Officially in fact and law the valid standard is EN ISO/IEC 80079-34:2011 – based on the previous version ISO 9001:2008. Actually, most of the manufacturer apply the new ISO 9001:2015.

Otherwise ISO/IEC 80079-34:2018 is confirmed, but currently not as finalized EN standard.

Thus, it is practicable and reasonable to use applicable parts of prEN ISO/IEC 80079-34:2017. It is under the responsible position of the Notified body and its auditor(s) to adduct appropriate and relevant parts respectively of this new standard.

Answer:

Recommendations (of the QM-WG 04/13 for the months until publishing the new European Standard based upon ISO/IEC 80079-34:2018):

Considering most of the manufacturer apply the new ISO 9001:2015

It is proposed to use ISO/IEC 80079-34:2018 with the following schedule :

- from now, ISO/IEC 80079-34:2018 + Annex ZB of EN ISO/IEC 80079-34:2011,
- when prEN ISO/IEC 80079-34 based upon ISO/IEC 80079-34:2018 will be published, ISO/IEC 80079-34:2018 + Annex ZB of prEN ISO/IEC 80079-34 based upon ISO/IEC 80079-34:2018,
- when EN ISO/IEC 80079-34 based upon ISO/IEC 80079-34:2018 will be published, the complete new European version.

The audit report should contain the relevant references to the applied standards.

The QAN (QA certificate) may refer to the valid standard EN ISO/IEC 80079-34:2011 as current version or to prEN ISO/IEC 80079-34 based upon ISO/IEC 80079-34:2018 and/or ISO/IEC 80079-34:2018. It should be laid down in a recorded agreement between the auditor (on behalf of the NB) and the customer what should be done during the audit. E.g., the audit can be carried out based on EN ISO/IEC 80079-34:2011 with amendments following prEN ISO/IEC 80079-34:2018 based upon ISO/IEC 80079-34:2018. The QAN (QA notification as QA certificate according to the modules D or E, Annexes IV or VII) does not contain

any references to the ISO/IEC standard. The QAN only confirms that the manufacturer is establishing and maintaining a quality assurance system for the production/final inspection according to the relevant annexes of the directive 2014/34/EU. The reference to the applied standards is exclusively provided by the underlying audit report.
